Course Code Release: 2017-18 School Year

CTE

Approved local course options (LCOs) and requested Community College Career and College Promise (CCP) course codes have been added.

World Language Level IV High School Codes for Middle School Students

World Language Level IV middle school course codes for high school credit have been added for dual language/immersion languages:

- Cherokee
- Chinese
- French
- German
- Greek
- Japanese
- Spanish

Dual Language/Immersion

If you have students in a dual language/immersion program who are taking a standard content area course in the target language (e.g., Math in Spanish, Social Studies in Chinese, Science in French, etc.), please use the following coding scheme:

- Place an "L" in the 8th local digit of the code
- Rename the "Course Name" field in the following format: [State Course Title] DL/I

IB World Language "Other Language" Codes

Two new IB Language B- Other Language (SL and HL) world language elective course codes have been added (1I278X0 and 1I288X0). These course codes should be used for IB world language courses that do not have a language - specific course code assigned. Please rename the "Course Name" field with the specific language taught.

OCR/CRDC Update

Dear OCR Coordinators,

Please forward this email to other staff as appropriate. Note: Those LEAs and Schools that were not open in the school year 2015-16 are not required to participate in this collection.

The PowerSchool Submission End dates for the CRDC will be updated to February 1, 2017. Please do not Approve the LEA level reports until notified by the NC DPI. Continue to run the LEA level CRDC PowerSchool Preview reports and notify the NC DPI of any concerns.

The Federal Submission Portal is currently scheduled to open in late January or early February 2017. To check for updates from the Feds, click <https://crdc.grads360.org/#program>.

The CRDC Grads360 Workgroup is open to users. Here is where staff can review the CRDC webinars and ask questions of their peers. The CRDC Grads360 Workgroup link is located on the right side of the CRDC Grads360 homepage. To request access, contact Molly Hash at molly.hash@aemcorp.com.

B) The PowerSchool CRDC Data Dictionary has been updated to:

1. Include additional information regarding the collection of data for students passing math courses. The Stored Grades screen requires a value greater than or equal to 70 must be populated in the Percent field.

These documents are already located on the CRDC Grads360 NC Workgroup site.

Deployed Fixes:

1. Charter schools that did not have AIG programs were indicated as having a program by the indicator 'Yes' on the PowerSchool CRDC Part 1. This error could be seen in the data view 'CRDC School Detail – Part 1'. A resolution was deployed into PowerSchool during the November Home Base maintenance weekend.

2. EDDIE grade levels in the CRDC EDDIE Grade Level screen were inadvertently deleted for districts with a leading zero in their LEA number (010, 020, 030, 040, 050, 060, 070, 080, and 090). A resolution was deployed in mid-November.
3. The Alternative school setting on the CRDC School level screen and on the PowerSchool were incorrectly set to 'No' and users were unable to further identify the type of Alternative learning program that was offered. The School level screen was updated to accurately reflect the data coming from the EDDIE system November 23, 2016. If your data does not appear to have updated, please contact the Home Base Support Center.

Fixes Pending December Maintenance weekend:

1. The Special Education data on the PowerSchool CRDC Preview Part 1 report is incorrectly reporting as 'No' for those schools that have updated the EDDIE system. This issue will be resolved during the December PowerSchool Maintenance weekend.
2. The CRDC School screen is indicating that schools provide PK services. The screen may be looking at enrollments within the LEA's DPI FTE School. This issue is scheduled to be resolved during the December PowerSchool Maintenance weekend.

- Do all your students have an FTE value in their 2015-2016 school year enrollment record? If you are unsure how to check or how to update, please contact the HBSC support center for assistance on this process.

- Did you know that the school level CRDC PowerSchool Preview reports contain views that allow you to see the actual students who are being counted in the reports?

Attention Coordinators,

If you have future schools or closed schools in PowerSchool, please make sure your setup is updated to show them as currently non-reporting schools of state compliance reports (SCRs), such as PMR, SAR, etc. This will reduce the

amount of time spent in determining if a school should have run a report, and enable NCDPI to contact those that should have reported sooner.
