## GDV Correction Window Opens Monday, July 31

The correction window for the Final Graduation Data Verification Report will begin Monday, July 31 and is set to end Sunday, August 13. This report is purposed for facilitating corrections to data, if necessary. LEAs/schools may make adjustments and corrections up until COB, August 13. **This correction window is the only opportunity to make adjustments.**

All mid-year and summer graduates were transferred to the “Graduated Students School” (School #999) during the PowerSchool EOY process. Therefore, all data changes/corrections should be made in the “Graduated Students School” in PowerSchool.

LEAs must re-run the Final GDV report after any changes so the user can verify the correction, and NCDPI can receive the changes. If there are no edits/corrections needed, schools will not have to re-run their reports. LEAs should make sure the report has run the first day.

**PLEASE NOTE:** This data is used in the calculation of the Cohort Graduation Rate (CGR) for Accountability Services. If you do not re-run the report after making changes, NCDPI will not receive the changes.

## Enroll Student in Remote/Summer School Class Functionality

The Enroll In a Class at Another School screen was updated with the release of PowerSchool 10.1.3 to display the menu selection on the student’s Function screen as Enroll Student in Remote/Summer School Class. After implementing the new functionality, the following issues were reported:

- The submit button to save the user’s selection disappeared in some instances.
- When selecting a school, only a limited number of courses were being returned.

To resolve these issues, PowerSchool re-installed a previous version of the screen. This fixed the above issues; however, another minor issue has been noted in the navigation path where the text reads, “String key was not found!”. This issue will be resolved at a later date. ## Dual Language Immersion Survey

Beginning 2017-18, class size requirements for kindergarten through third grade shall not apply to dual language immersion classes. Dual language immersion classes are classes in which at least one third of the students' dominant language is English, and instruction involves both English and a target foreign language with a minimum of fifty percent (50%) of core content taught in the target foreign language in order to promote dual language proficiency for all students.

NCDPI is collecting a list of the K-3 dual language immersion classes in order to exclude those classes from average class size reports and applications. This dual language immersion classes survey is to be completed by each LEA for school year 2017-18 to comply with Session Law 2017-57.
