## Home Base Maintenance Weekend - October 14 - 17, 2016

The next Home Base maintenance weekend is scheduled for Friday, October 14 through Monday, October 17. Maintenance will be performed on the PowerSchool and Truenorthlogic (TNL) applications. TNL maintenance will occur within the time frame of the PowerSchool maintenance.

PowerSchool will shut down Friday, at 5 p.m. Once maintenance is completed, a message will be sent to notify users that the system is up and available for use. PowerSchool will be returned to service no later than 6 a.m., Monday morning. If a delay in bringing up the system should occur, users will be notified via email.

**Affected Systems:** Remedy

**Note:** Users of Remedy will not be able to submit tickets.

**Outage Span:** Saturday, October 22, between 1 p.m. - 2 p.m.

## Assigning Post-secondary Staff to Courses

Complete schedules for students and teachers are required for accurate SAR reporting. Starting with the 2016-17 school year's reporting of data, NCDPI has created generic UIDs for university, community college and independent college instructors.

## Class Size

During the SAR collection process, Average Class Size data is produced. This is the data that is reported in the School Report Card.

It is imperative to review the Class Size report during the SAR collection to assure the data is accurate. When the collection has ended and the SAR has been approved, the Average Class Size data for 2016/17 is also approved.



The SAR Class Size report will show what sections are being used for the average class size calculation, the number of lead teachers assigned to the sections and the number of students in the sections along with other section details. The report view will be shown by grade level.

EC data files were recently received for non CECAS users, and will be loaded into PowerSchool. Once that data is loaded, verify your EC data in PowerSchool for this calculation. Without this data, EC sections may have incorrect averages.



## Master CN Linker File

We are pleased to announce that the new Master Child Nutrition (CN) Linker File will be loaded into PowerSchool this weekend. This file can only be run at the LEA level. LEAs and charters will not be able to use the file until their Meal Eligibility vendors update their systems to work compatibly with these changes.

The new Master CN Linker File provides twice as much student demographic data, allowing the vendor and districts to choose what data is needed. It will replace the need for Linker Files 1509, 1708 and 1546. Thus, these files will eventually phase out. More information will be provided on the deadline for vendors to become compatible with the new Master CN Linker File and the date for removing these files from PowerSchool.

The navigation path for locating the Master Child Nutrition Linker File is *Start Page > State Reports > NCDPI Reports Tab*.
