Maintenance Planned for the Remedy Ticketing System - Oct. 1

The previously postponed maintenance window for the Remedy ticketing system will now occur Saturday, Oct. 1, from 1 p.m. - 6 p.m., ET. Both, Remedy and the customer self-submit web portal will be unavailable during this time.

The planned maintenance will include a server migration to a new data center. Once completed, if there is a delay in bringing up the system, users will be notified.

Deadline for Recording Read-to-Achieve Status in PowerSchool

Previously, we communicated that LEAs and charters must complete the 2016 Post-EOY process to record Read-to-Achieve statuses in PowerSchool by close of business, Friday, September 30, 2016. This deadline is being extended to **close of business, Friday, October 7**.

During this process, the student's promotion status in the PowerSchool EOY enrollment record is updated to reflect the Retention – Reading label. Test scores are entered by NCDPI Accountability, so there is no need for districts to enter them.

First Month Principal's Monthly Report Submission Reminder

As we near the end of the collection period for month 1 of the Principal's Monthly Report, please make sure you have submitted your PMR within the collection timeframe determined by your PMR interval calendar. If you have missed your submission end date, request to have the report unapproved by submitting a Remedy ticket

to the support center.

In addition, check your reports for the following:

- Make sure all fatal errors have been cleared and if you are unable to clear the fatal exceptions, log a remedy ticket with the support center immediately.
- Review all remaining exceptions to confirm you are submitting the data you intend to report for the LEA.
- Use the ADM column on your PMR as a guide to determine if you have reported all students correctly. Please note that the ADM column on your PMR report is an unofficial count until the data has been verified by NCDPI.

Also, remember to check your Grade, Race, Sex (GRS) report, which is attached to your 1st month PMR, for fatal error exceptions such as PMR 8 (Students not assigned to a Valid Race/Ethnicity) that will affect the accuracy of the data submitted.

Retention/Promotion (RP)

The collection time-frame for the RP report is September 23, 2016 through October 27, 2016. Please run the report in PowerSchool and review the data for accuracy.

The RP collects only data for students that were in membership on the last instructional day of 2015/16. VST1 students are not included in this data collection.

Please note that currently the report title reads, "Retention/Promotion/Graduation Data Collection in PowerSchool." The title will be changed in the future to "Retention/Promotion Data Collection."

There are also a couple of lines on the RP Summary that indicate graduate data. These also will be removed in the future. The RP is not collecting graduate data, and we apologize for any confusion the screen views of the report may have caused.
